Act XXVI of 1961*) instead of the West Bengal Co-operative Societies Act, 2006, in accordance with the decision taken in the meeting of the 7th State Level Technical Steering Committee of WBADMIP on 24.07.2012;

NOW, THEREFORE, for the purpose of effective implementation of the said Schemes, the Governor is pleased hereby to make the following amendments in the said Schemes:—

(2) in rule 12,—

- (a) in clause (k), for the words and figures “the West Bengal Co-operative Societies Act, 2006”, *Substitute* the words and figures “the West Bengal Societies Registration Act, 1961,”;
- (b) in clause (l), for the words and figures “the West Bengal Co-operative Societies Act, 2006”, *Substitute* the words and figures “the West Bengal Societies Registration Act, 1961,”;
- (c) in clause (m), for the words and figures “the West Bengal Co-operative Societies Act, 2006”, *Substitute* the words and figures “the West Bengal Societies Registration Act, 1961,”;
