The issue of movement to pre-revised scale No. 20 (Revised level-22) from pre-revised scale No. 19 (Revised Level-21) for the Superintending Engineer / Additional Chief Engineer belonging to West Bengal Senior Service of Agriculture Engineers under administrative control of Water Resources Investigation & Development Department who has completed 27 years of continuous and satisfactory service starting from Assistant Engineer but has not become eligible for promotion to the post of Chief Engineer by such time, has been under consideration of the Government for sometimes past.

- 2) After careful consideration of the matter, the Governor has been pleased to allow 07(seven) number of Superintending Engineer / Additional Chief Engineer of Agri-Irrigation wing and 05(five) number of Superintending Engineer / Additional Chief Engineer of Agri-Mechanical / Electrical wing of Water Resources Investigation & Development Department holding from pre-revised scale No. 19 (Revised Level-21) to move to pre-revised scale No. 20 (Revised level-22) on the following terms and conditions:-
 - (i) Such movement will be purely on non-functional basis;
 - (ii) They will be designated as Superintending Engineer (Selection Grade) / Additional Chief Engineer (Selection Grade);
 - (iii) As and when an Additional Chief Engineer (Selection Grade) of either wing will fall vacant, the same will be abolished and converted to Superintending Engineer (Selection Grade) till the time the numbers of Superintending Engineer (Selection Grade) in Agri-Irrigation wing and Agri-Mechanical / Electrical wing of Water Resources Investigation & Development Department will remain as 7 & 5 respectively;
 - (iv) Their jobs including authorities will remain the same as other Superintending Engineers / Additional Chief Engineer (as the case may be);
 - (v) Such movement will be allowed to the Superintending Engineer / Additional Chief Engineer (as the case may be) after completion of 27 years of total service starting from Assistant Engineer provided that such officer has not become eligible for promotion to the post of Chief Engineer by such time;
 - (vi) While allowing such scale, norms of promotion will be followed but fixation of pay will be in accordance with the Rule 42 (II) of W.B.S.R. Pt.-I;
 - (vii) When their term for promotion to the post of Chief Engineer will come, they will be promoted as such in the same Revised Level-22 on functional basis;

- The norms for such movement regarding ACR / SAR Rating will be in (VIII) accordance with 1326-PAR (WBCS)/ID-266/18, dt. 08.11.2019 issued by the Department of Personnel & Administrative Reforms; (ix)
- Necessary screening will be done by the Departmental Promotion Committee.
- This order will take effect from 09.03.2018, i.e. the date of issue of Finance Department's earlier U.O. bearing No. 0450 dt. 09.03.2018 which has stood cancelled to that effect with the issue of current Finance Department's U.O. No. Group P1 / 2021 - 2022 / 0196, dt. 07.09.2021 in this regard.
