Ltd. and Anr. -Vs.- the State of West Bengal and Ors.) and the Managing Director, West Bengal Agro Industries Corporation Limited has also expressed inability to supply the said materials and cancelled the agreement executed between the WBAIC Ltd. and the Aroni Agri Equipment Pvt. Ltd. relating to said NIT 23 of 2010-11, therefore, the said items may now be procured following the usual procedure as outlined in the said Notification.

This order shall take immediate effect.


