MEMORANDUM

The system of LOC for withdrawal of fund for works expenditure has been discontinued with effect from 1.4.2015. The salient features of the substitute procedure of drawal of fund related to works expenditure through Treasuries / Pay & Accounts have been prescribed in the Finance Department's Memo. No. 736-F(Y) dated 10.2.2015, No. 2705-F(Y) dated 30.3.2015 and 3546(9)-F(Y) dated 5.5.2015.

For incurring petty expenditure each DDO (Drawing & Disbursing Officers) has been allowed to draw permanent imprest of Rs. 10,000/- under Rule 89 of WBFR. The procedure of drawal of Permanent Imprest of Rs. 10,000/- by each DDO has been clearly laid down at clause-4 and clause-20 of Finance Department's Memo. No. 2705-F(Y) dated 30.3.2015.

Finance Department, Gr.-T has sanctioned an amount of Rs. 10,000/- as Permanent Imprest in favour of each of the 61 DDOs under this department as mentioned in the Annexure, vide their UO No. Gr.-T/2015-16/0336 dated 31.7.2015. Finance (Budget) Department vide their UO No. 1147 dated 11.8.2015 has agreed to drawal of Rs. 10,000/- (Rupees Ten thousand) only as Permanent Imprest by each of the abovementioned 61 DDOs from the Head of Account of "8672-00-101-026-WRI&DD-10-Payment".

Under the circumstances, after careful consideration on the matter, the undersigned is directed to convey the sanction of this department towards drawal of Permanent Imprest of Rs. 10,000/-(Rupees Ten thousand) only by each of the 61 (Sixty-One) DDOs of this department from the concerned Treasuries / Pay & Accounts Offices as mentioned in the Annexure under Col. 3 and 4 respectively for incurring petty expenditure such as casual hiring of vehicles for a period not more than 10 days in a month in accordance with the Notification of Transport Department No. 3564-W 1/3M-81/98 dated 24.11.2008, petty purchase, emergent payment of telephone, internet and electricity bills, hiring of casual workers for survey or other purposes and such other payments booked under the detailed heads "19/27/53" subordinate to Major / Sub Major / Minor / Scheme heads under Non Plan / State Plan Works Budget provisions of the department under Demand No. 55, subject to compliance of the guidelines set forth in the Finance Department Memo. No. 2705-F(Y) dated 30.3.2015. The Permanent Imprest shall be drawn in TR Form-31 subject to recoupment on presentation of contingent bills in TR-26.
