After careful consideration, the Governor, is, therefore, pleased to provide relaxation of credentials in respect of execution of any type of Civil works, maintenance works, supply of materials/articles etc. having a value up to Rs 10.00 lakh under this Administrative department.


Moreover, the following documents are prescribed for determining the eligibility for selection of this category of contractors.

1. Trade License.
2. PAN Card
3. Professional Tax payment challan/Receipt (up to date)/GST Number
4. Electrical Supervisory License/Certificate for Electrical works only.
5. Any other documents/certificates as deemed essential by the Tender inviting Authority.

Intending bidders shall submit above documents while participating in the bid process in connection with these tenders. Besides, Tendering Authority while floating these tenders shall abide by necessary conditions as laid down in Notification no 5400-F(Y) dated 25-06-2012 and other Notifications/Orders issued from time to time regarding Publication of tender.
