Whereas, **MSME** Department has approached to WRID Department to consider bringing MSME units not using groundwater for any Industrial purposes and planning to extract Ground water for **Drinking or Sanitation or Hygiene** purposes up to **5 KLD** under exempted category,

And

Whereas, the matter has been examined by SWID and recommended to WRID Department to consider bringing MSME industries including Large and Medium scale Industries ,Commercial enterprises, Mining projects drawing Ground Water only for **Drinking or Sanitation or Hygiene** purposes up to **5 KLD** under exempted category ,

And

Whereas, the competent authority in the State Government has accepted the recommendation in the public interest,

Now therefore, in exercise of power vested vide **Section 7 (1) of WBGWR Act, 2005**, the Governor is hereby pleased to exempt the following category of users from the purview of Permit

MSME Industries/ Commercial Enterprises having Udyam Registration and performing manufacturing/ servicing/business activity where water is neither consumed in manufacturing process nor any Industrial waste water effluents are produced during manufacturing/ servicing/business activity and where water is used less than 5 KLD for drinking/ sanitation/hygiene purposes.
2.	Other users
	All Large & Medium Industries/ Mining projects drawing ground water only for drinking/sanitation/hygiene purposes up to 5 KLD.
